



## **Specifications for the organization of the FMBB World Championships Obedience**

---

### **1. General Provisions**

- a. The WC Belgian Shepherd organizing country will uphold the following regulations. In cases of doubt or possible exceptions, always contact the FMBB Obedience Commission or the FMBB Board.
- b. The FMBB Obedience qualifications and finals trials have to be held under the International Obedience Competition rules and guidelines of the FCI classes 1, 2, 3, regarding the performance and the evaluation of the exercises during the competitions .

### **2. Composition**

The FMBB Obedience World Championship has following titles.

1. The FMBB Obedience World Championships (class 3).
2. The FMBB Obedience World Winner class 1.
3. The FMBB Obedience World Winner class 2.

### **3. Competitors**

- a. Competitors have to have the qualification for the class they are entering.
- b. Once a dog has participated in a competition or exam in a certain class, regardless of its performance, it is not eligible to compete in a lower class at FMBB.
- c. A handler can compete with the maximum number of two (2) dogs in the same class or different.
- d. A handler or a dog cannot compete in other disciplines at the World Championship (except dog show).
- e. The maximum number of competitors per country is 12 with a maximum of 6 competitors in class 3. The positions are filled starting from class 3 downwards depending on the national club of each country.
- f. 2 reserves can be registered for class 3. The reserves should be listed in the catalogue. If any of the registered participants cannot take part because of illness/accident, they may only be replaced by the teams registered as reserves for this class.
- g. 1 reserve can be registered for classes 1 and 2 respectively. The reserves should be listed in the catalogue. If any of the registered participants cannot take part because of illness/accident, they may only be replaced by the teams registered as reserves for that class (i.e. a reserve, registered for class 2 cannot replace a competitor in class 1 or vice versa).

### **4. Judges, stewards and helpers**

- a. At least two judges with the qualification to judge internationally have to be invited. The Judge's List is proposed by the FMBB Obedience Commission. This with or without considering any

proposals sent in by the organizer, then approved and invited by the FMBB board. Following the judge's acceptance of the assignment, the organizer arranges all necessary documentation. At least one of the judges should be from another country than the organizing country.

- b. The Chief Judge is chosen by the Obedience commission among the invited judges. The name of the Chief Judge must be communicated to the FMBB board at least 3 weeks before the competition (i.e. 1 week after registrations close).
- c. One chief steward must be appointed. In addition, one extra steward or one experienced helper is recommended depending on the needs of the competition and the number of participants. However, having one chief steward and one experienced helper is mandatory. The ring stewards must have experience in conducting international or qualification competitions. All commands must be given in English.
- d. The Chief Steward is appointed by the organizer. The name of the Chief Steward must be communicated to the FMBB Obedience Commission at least 8 weeks before the competition. The Chief Steward alone is responsible for all communications with all the judges regarding terrain plans and equipment used.
- e. The Chief Steward must send all terrain and heelwork plans (qualifications and finals for all classes) to the judges 3 days after the close of registration for the event. The judges must agree on and submit requests for changes within 7 days after receiving the plans.
- f. The final approval regarding the order of the exercises, terrain and heelwork plans comes from the judges, as specified by the FCI Obedience rules. Once the judges approve the order and plans no further changes should be made.
- g. All judges and ring stewards must be able to speak English, which is the main working language of the FMBB. All other helpers must be provided by the organizer, in consultation with the Chief Steward. These helpers may come from the host country, provided they are not competing in the class they assist. For example, competitors who have finished their trial in Class 1 may assist in Classes 2 and 3.
- h. If the number of registered competitors exceeds the FCI allocation for judging per day for the 2 invited judges, additional judges (and a sufficient number of stewards and helpers) must be invited.

## **5. Competition field**

- a. The competition ground has to be sand, grass or artificial grass if outside, an acceptable floor, sand or artificial grass, if it will be held indoors. The ground should be flat and in such condition that there will be no danger for handler or dog.
- b. The minimum size of the ring is written in the FCI rules. In addition there should be enough space to prepare the dog without disturbance by spectators or free running dogs
- c. The qualifications should take place in one ring. The exercises may be divided into 2 rings only if there are more than 25 competitors entered in one or more classes.
- d. The finals take place in 1 ring only with 2 judges judging simultaneously. This is obligatory for class 3, classes 1 and 2 final competition may be divided into 2 rings only in the case that the number of competitors in the final run exceeds the FCI allocation for judging per day.
- e. The competition field has to be measured, prepared and marked exactly.

## **6. Equipment**

- a. All equipment has to conform to FCI rules.
- b. Sufficient equipment for all classes has to be available. The wooden sticks for the scent discrimination exercise must be new for each competitor. Dumbbells provided by the

organization should be new and have to be available in three sizes, however, and following FCI rules, competitors may use their own dumbbells if they choose to do so.

- c. The equipment has to be organized by the Chief Steward and has to be approved by the FMBB Obedience Commission and the judges.
- d. If a second ring is needed, enough equipment has to be available.

## **7. Performance of competition**

- a. All starting numbers for the qualifications have to be drawn by lottery.

Competitors with two dogs are to be considered if both dogs are in the same class.

The starting order of the finals is determined by the reverse order of results achieved in the qualification round.

- b. The competition is to be held in the following way:

- Each class is held over two days.
- First day all competitors are doing one trial, the second day is held as a final with a maximum of 20 starters. If there are less than 20 starters in a class, all starters in this class are competing two times irregardless of the result achieved on the first trial day.
- The lower classes (1 and 2) are held on the same day, the highest class (3) on another day, so 4 days are needed for the Obedience competition.

- c. Individual competition

- To determine the final ranking, the points from both trials must be added together. The top three competitors in each class must be awarded.
- Class 3 competitors will receive official FMBB medals during the closing ceremony, together with the other dog sports.
- Classes 1 and 2 will receive their awards on the field immediately after the conclusion of their respective competitions.

- d. Team competition

The total points from the best three in class 3 per country makes the result for the team competition.

- e. Final Competition

At least the final class 3 competition must be judged by two judges simultaneously, but preferably this should be the case for final competitions in all classes

## **8. Trials and training**

- a. The plan of the ring, the heelwork and the order of exercises for the first day of completion have to be published 2 weeks before the competition at the organizers homepage and have to be sent at the same time by e-mail to the team leaders. It is highly recommended to also publish the used equipment.
- b. The positions for the qualifications in all classes should be announced during the team leader meeting (FMBB regulations prevails to FCI).
- c. The order of the exercises, terrain plans, heelwork, and positions for the finals have to be published after the first day competition (Thursday evening for classes 1 and 2, Friday evening for class 3, FMBB regulations prevails to FCI)..
- d. Training has to be organized for all competitors. 5 minutes per competitor are recommended. All trainings have to be held on Wednesday, before the competition of any

class starts.

- e. The equipment used in the competition has to be prepared; also the ring has to be prepared for the class.
- f. The Chief Steward must ensure the terrain plans are communicated directly and only to all the invited judges. All the invited judges are also responsible for approving all terrain plans for the competition.
- g. A white dog may be any dog, handled by any person, provided that neither the dog nor the handler is competing in the class being demonstrated. A handler who has already completed their competition in their own class may also present the white dog.

**9. Time table** (can be adjusted depending on the number of registered participants)

a. Wednesday

- Veterinary control
- Training for all classes
- Judges meeting
- Team leader meeting and start number drawing

b. Competition

- Thursday: Class 1 & Class 2
- Friday: Class 3
- Saturday: Final Class 1 and Class 2
- Sunday: Final Class 3

c. Office

A time and room has to be provided for the drawing and briefing, team leader meeting, judges meeting and Obedience committee meeting.

**10. FMBB Obedience Commission - Purpose of the commission**

- a. Assisting in the organization of the FMBB world championships Obedience.
- b. Decide upon issues that may cause several interpretations with regard to regulations.
- c. Approves necessary changes of the schedule (in cooperation with the organization if necessary)
- d. Brief judges.
- e. Communication with the next organizing committees and the FMBB Board.
